Positions held at, and activity occurring in, your Paxos account can be identified in each section under the heading "Assets Held at Paxos", "Trades Executed at Paxos", or in line items labeled "at Paxos".

None of the other information or footnotes in this document apply in any way to the digital asset portions of this document.
